The institution of affiliation shall be expected to provide the Project Director, or a scholar awarded a project under Clause 4, with facilities such as accommodation for work, including furniture as specified in respect of a Fellow in Clause 15 of Chapter II of these Rules, and shall be paid overhead charges in return thereof by the ICHR

The grants-in-aid are subject to fulfillment of the conditions laid down in the ICHR Research Funding Rule for Grants-in-aid for research project and also subject to the following conditions:

- (a) The Project Director, Dr. Kishori Lal will be responsible for directing the project to its completion within the stipulated time and sanctioned budget/grant from the date of the commencement of the work, which may please be intimated to this Council immediately.
- (b) The Head of the Institution will have to share the responsibility for the proper utilization of the grant and also for the completion of the work on time and the receipt of the final report of the study.
- (c) In case the sanctioned amount is not utilized in time the reasons for the same will have to be intimated to the council. This is regarding your proposal submitted under Star College Scheme that was presented in the 12th Meeting of Task Force on Star College Scheme to evaluate of the proposals under Urban Category on 11th-12th April, 2022 via Video Conferencing. The following comments were noted:

" The proposal was presented by the coordinator, Dr. Maneesha Kohli. The Screening committee after discussion had appointed Dr. Hemlata K Bagla and Dr Rama Govindarajan, as the mentors for the college.

The Task force observed that the proposal was well presented. The College may be considered for support under the Star College Scheme considering the large number of beneficiaries and location of the College. Some equipment required for practical proposed were not mentioned. The college should revise the list of equipment proposed according to the practical listed in the proposal. The college should also make efforts to increase number of faculty in all departments. The college should contact Dr Sanjeev Puri for mentorship.
