Annual report for session 2018-19

During the academic session 2018-19, Women Cell and POSH Committee organized four meetings to review and plan activities related to gender sensitization and safety in the college. The meetings were attended by the staff as well as student members. The faculty representatives to these meetings include Dr. Sarita Sharda (Convener), Dr. Bharti Sharma (Coordinator), Dr. Meenakshi Sharma, Ms. Poonam, Mrs. Mona Sharma, Mrs. Sachi Sood, and Mrs. Reetika Chandel. The student members were Ms. Jhanavi Thakur and Ms. Sonika Thakur, both in BA 3rd year.

In the first meeting organized on 3rd July 2018, at the beginning of the academic session, a general house for all the 1st-semester students was also organised in the college auditorium to create awareness related to Anti-Ragging laws as well as sexual harassment.

On 18th September the Women Cell organized the screening of an inspirational film Nil Battey Sannata based on the theme of a person's right to dream and change their life, irrespective of social status. The film screening in the college auditorium was well attended by the students and the staff members.

On 1st December 2018, the Women Cell commemorated World AIDS Day by organising a special lecture by Swati Sharma on sexual wellness, especially for young women. She also conducted an interactive session on LBGTQ+ issues and challenges. The event organized in the college auditorium was well attended by the college students.

On 8th March 2019, to commemorate International Women's Day, a special lecture by Dr. Nishi Sud. Obstetrician and Gynecologist in Kamla Nehru Hospital Shimla was organized for girl students. She sensitised the audience about gender equality and menstrual hygiene. She also talked about the role of social media in breaking gender stereotypes.

Annual report, 2019-20


On 17th July 2019 Women Cell and POSH Committee convened a meeting to induct new members and plan year-long activities for gender sensitization and safety in the college. It was planned to induct new Gender Champions and organise awareness programmes and events. It was also resolved to provide professional sexual health counseling, and personal counseling to the students. The faculty and staff representatives to the meeting included Dr. Sarita Sharda (Convener), Dr. Gian Chand, Dr. Bharti Sharma, Dr. Meenakshi Sharma, Mrs. Anupama Chowdhary, Mrs. Sachi Sood, Mrs. Reeta Chandel, and Mrs. Satya Devi. The student members included Ms. Babita Bhardwaj (B.Sc. 1st year) and Mr. Vivek (B.Sc. 2nd year).

On 30th August 2019, Ms. Yogita Dutta, a senior advocate of the Himachal Pradesh High Court delivered a lecture on legal provisions for women's rights and sexual harassment to 270 students. The lecture was followed by an interactive session.

On 25th October Dr. Himang Jareik and sister Surekha Gupta of Zonal Hospital, Shimla held an interactive programme in the college auditorium packed with male and female students on sexual health and prevention of STDs. Questions and opinions collected by Gender Champions reported in an anonymous survey amongst the audience generated a large number of talking points for the session. Awareness pamphlets were also distributed to the audience.

On 7th December 2019 in a meeting of POSH Committee the faculty members reported personal counseling issues provided to a few students. One case was referred to the Psychiatry Department of the Indira Gandhi Medical College and Hospital.

Due to the tragic accidental death of the Convener Dr. Sarita Sharda and Covid-19 other events of the Women Cell and POSH Committee for the year, including the commemoration of the International Women's Day on 8th Match 2020 were suspended awaiting further instructions from the higher authorities.

Report for Session 2020-21

On 30th July 2020 Women Cell and POSH Committee convened an online meeting to plan the activities of their activities while facing the challenges of the Covid-19 pandemic. It was resolved to organize meetings of the Internal Complaints Committee (ICC) bi-annually. It was also resolved to focus on counseling and online discussions to enable students to share stress and traumas related to stress and exploitation in confined spaces. The faculty representatives to the Cell included Dr. Bharti Bhagra (Convener), Dr. Bharti Sharma, Dr. Meenakshi Sharma, Dr. G.P. Kapoor, Dr. R.L. Sharma, Dr. Ruby Kapoor, Ms. Maneesha Kohli, and Ms. Himani Saxena. The student members included Ms. Vanshika (B.A. 1st year) and Ms. Sargam (B.A. 2nd year).

On 11th November 2020 a meeting was held to reconstitute the ICC. On 13th November 2020, the ICC was constituted with the following members: Dr. CB Mehta (College Principal), Dr. Bharti Bhagra (Convener), Dr. Rajesh Dhorta, Dr. R.L. Sharma, Dr. Kamna Mahendru, Dr. Bharti Sharma, Advocate Yogita Dutta (external member), Ms. Geeta and Ms. Kirta.

On 24th, 26th and 28th December 2020 three sessions on Constituents of Domestic and Gender Violence were conducted by Advocate Yogita Dutta. With deference to physical distancing guidelines of Covid-19, only 80 students were allowed in each session.

On 13th February 2021, the following members were added to the Women's Cell and POSH Committee: Dr. Kamna Mahendru, Dr. Sandhya Sharma, Dr. Rubu Kapoor, Mrs. Namita Khagta, Dr. Kamyani Bisht, Dr. Shivani Khatri, Dr. Monika Chandel, Mrs. Saachi Sood, and Dr. Poonam Verma.

Two meetings of the ICC were held on 16th November 2020 and 29th March 2021. It was reported that no complaints related to sexual harassment were received in the respective periods. Both reports were sent to the Directorate of Higher Education.





Zero Tolerance to Sexual Harassment and Gender Discrimination



Centre of Excellence Government College Sanjauli, Shimla Himachal Pradesh

Introduction

Our college recognizes that sexual harassment and gender discrimination are pervasive problems that negatively impact our community. Sexual harassment and gender discrimination undermine the safety, dignity, and equality of our students, staff, and faculty. We are committed to creating a safe and inclusive environment where everyone is treated with respect and dignity. Therefore, we have developed a policy of zero tolerance towards sexual harassment and gender discrimination in all its forms.

Policy Statement

Our college is committed to providing a safe and inclusive environment free from sexual harassment and gender discrimination. We recognize that sexual harassment and gender discrimination are serious violations of human rights that undermine the dignity, safety, and equality of individuals in our community. Therefore, we have developed a policy of zero tolerance towards sexual harassment and gender discrimination in all its forms.

Sexual Harassment: Any unwelcome sexual behaviour that creates an intimidating, hostile, or offensive environment. It includes physical, verbal, or non-verbal conduct of a sexual nature, such as unwanted touching, comments or jokes of a sexual nature, displaying sexually suggestive images, or making sexual advances. Sexual harassment can occur between individuals of the same or different genders, and can occur in any context, including in person or online.

Gender Discrimination: Our college also recognizes that gender discrimination is a serious problem that undermines the equality and dignity of individuals in our community. Gender discrimination refers to any unequal treatment based on gender, including discrimination based on gender identity or expression. This includes denying opportunities or benefits to individuals based on their gender, as well as creating a hostile or offensive environment based on gender.

Legal Provisions

The college's policy on sexual harassment and gender discrimination is consistent with the following legal provisions:

- The Vishaka Guidelines, issued by the Supreme Court of India in 1997;
- The UGC's Saksham Measures for Ensuring the Safety of Women and Programmes for Gender Sensitization on Campuses;
- The University Grants Commission (Prevention, prohibition and redressal of sexual harassment of women employees and students in higher educational institutions) Regulations, 2015.

Women Cell and Prevention of Sexual Harassment (POSH) Committee

The college will have a Women Cell and Prevention of Sexual Harassment (POSH) Committee responsible for implementing the college's policy on sexual harassment and gender discrimination. The Women Cell will be headed by a senior woman faculty member of the college. The POSH Committee will be made up of representatives from the college administration, faculty, and students.

The mandate of the Women Cell and POSH Committee will be to provide a variety of services relating to sexual harassment and gender discrimination. These activities will be divided in two broad categories:

- Prevention of Sexual Harassment and Gender Discrimination, including providing information and resources, and sensitization about sexual harassment and gender discrimination
- Remedies for Sexual Harassment and Gender Discrimination, including counseling and support, and support in the complaint process

The Women Cell and POSH Committee are committed to creating a safe and inclusive environment for all students, faculty, and staff. All stakeholder will be encouraged to contact and consult contact the Women Cell or POSH Committee in case of questions or concerns about sexual harassment or gender discrimination in the College.

The names and contact information of Women Cell or POSH Committee members will be prominently displayed on the College website as well as at prominent places in the College campus.

Prevention of Sexual Harassment

- The prevention of sexual harassment is an important part of our commitment to creating a safe and inclusive environment. The preventive framework will include:
- Sensitization and training to all employees and students on the prevention of sexual harassment and gender discrimination along with the procedures for reporting and addressing complaints.
 Focus area of sensitization and training will include topics such as:
 - identifying sexual harassment;
 - identifying gender discrimination;
 - the impact of gender discrimination on individuals and the community;
 - the impact of sexual harassment on individuals and the community;
 - strategies for preventing sexual harassment; and
 - strategies for preventing gender discrimination.
- In addition to training, the college will also take steps to create a culture of respect and inclusion. This includes promoting respectful communication, addressing stereotypes and biases, and encouraging open and honest dialogue about issues related to gender and sexuality.
- The college will also provide resources and support services to individuals who have experienced sexual harassment or gender discrimination.

Reporting Sexual Harassment and Gender Discrimination

We encourage all members of our community to report incidents of sexual harassment/gender discrimination. Reports can be made to any staff member or faculty member, and will be treated with sensitivity and respect. Complaints can also be made anonymously if desired.

Complaint Procedure

- Who can file a complaint: Any student, faculty member or personnel from the college administrative staff, who believes that they have been the victim of sexual harassment or gender discrimination is encouraged to report the incident.
- **To Whom:** A complaint can be addressed to either the POSH Committee or any individual member of the Post Committee.
- How: A complaint can be made in person, through email or in writing.
- **Confidentiality:** All complaints of sexual harassment and gender discrimination will be handled in a confidential manner to the extent possible. All members of the Committee, including the Coordinator, will take all necessary steps to protect the confidentiality of the complainant and the respondent.
- **Protection of Complainant:** The college will also take steps to ensure that the complainant is protected from retaliation or further harassment.

Remedies

The college takes allegations of gender discrimination seriously and will take appropriate action against individuals who engage in such behaviour.

- Upon receipt of a complaint, the college will initiate an investigation into the incident. The investigation will be conducted by a complaints committee, which will be composed of three members. The committee will be trained in the procedures for handling complaints of gender discrimination and will be independent of the parties involved in the complaint.
- The investigation will be conducted in a prompt and confidential manner. The complainant and the accused will have an opportunity to present evidence and witnesses to the committee. The committee will make a determination as to whether an offence has been committed based on a preponderance of the evidence. If the committee determines that an offence has occurred, it will recommend appropriate action to the College.

Sanctions for Sexual Harassment/Gender Discrimination

Sanctions for gender discrimination may include:

- Counselling
- Disciplinary action
- Termination of employment
- Expulsion from the college
