I. Introduction

The Faculty Development Programme (FDP) titled “Redefining Pedagogy: Legal Awareness, AI Integration, and Academic Integrity” was successfully organized by **Government College Sanjauli**, a prestigious institution recognized as a Centre of Excellence and accredited A+ by NAAC. The programme was conceived as a proactive step toward equipping faculty members with contemporary skills and interdisciplinary awareness essential for the rapidly evolving landscape of higher education.

As institutions of learning transition toward more technology-enabled, ethically sensitive, and legally responsible teaching environments, faculty must stay abreast of modern challenges and solutions.
